Robert Padilla was welcomed to the Habitat Restoration Workgroup (HRW); he is the new Primary member for Bureau of Reclamation (Reclamation). The agenda was approved with the addition of a closed discussion on the Velarde Reach A&R.
- Approve July 20, 2010 Meeting Minutes The July 20, 2010 HRW meeting minutes were approved with no changes.
- HR Project for Sept. 21 River Restoration workshop Reclamation is hosting a River Restoration workshop to share techniques used in river restoration. HRW has been invited to show pictures of habitat restoration projects during a working lunch. There was the question of whether or not HRW would be organizing the presentation; Terina Perez will ask Yvette McKenna if she would like HRW to organize the presentation.
- "Annual Report for the City of Albuquerque's Rio Bravo North and Rio Bravo South Habitat Restoration Projects: 2007-2008" Copies of a synopsis of the "Annual Report for the City of Albuquerque's Rio Bravo North and Rio Bravo South Habitat Restoration Projects: 2007-2008" were distributed. The format for the synopses was updated by Rick Billings and Colin Lee. A short presentation of the Population Estimation synopsis will be given by Rick, Sarah Beck, and Peter Wilkinson at the next regularly scheduled HRW meeting. There was brief discussion on whether the synopses should be captured by the Database Management System (DBMS); it was thought that the Executive Summaries of the documents would contain similar information and would be captured by the DBMS. It was thought that a list of documents would be helpful in choosing which documents should be summarized. Tetra Tech will check with Monika Mann to see if there is a pre-existing spreadsheet listing documents to be read and summarized.

- **Discussion of future short and long term direction for HRW** The HRW discussed future short and long term direction.
  - The HRW will need to begin working on Scopes of Work (SOWs) soon. It was not known when the Program Management Team (PMT) would be calling for SOWs; Terina Perez will find out when the PMT plans to call for SOWs.

Terina Perez will convey the need for visuals from contractors and the need for administrative support for the "State of the HR" workshop to Yvette McKenna.
  - It was thought there should be a stronger working relationship between HRW and other workgroups in the future; joint workgroup meetings should be focused and productive.

# **Meeting Minutes**

## Introductions and Changes to Proposed Agenda

- Rick brought the meeting to order and introductions were made around the table. Robert Padilla will be the Primary attendant of Habitat Restoration Workgroup (HRW) meetings for Bureau of Reclamation (Reclamation).
- The agenda was approved with the addition of a closed discussion on the Velarde Reach A&R.

### **Approve July 20, 2010 Meeting Minutes**

• The July 20, 2010 HRW meeting minutes were approved with no changes.

## "Annual Report for the City of Albuquerque's Rio Bravo North and Rio Bravo South Habitat Restoration Projects: 2007-2008" (Rick and Colin)

- Copies of a synopsis of the "Annual Report for the City of Albuquerque's Rio Bravo North and Rio Bravo South Habitat Restoration Projects: 2007-2008" were distributed. The HRW was reminded that this is part of an effort to keep HRW aware of ongoing projects.
- A short presentation on the "Annual Report for the City of Albuquerque's Rio Bravo North and Rio Bravo South Habitat Restoration Projects: 2007-2008" has been given at a previous HRW meeting. The formatting for synopses has been updated by Rick Billings and Colin Lee; this synopsis should be used as a template.
- A synopsis on Population Estimation will be presented at the next regularly scheduled HRW meeting. Rick Billings, Sarah Beck, and Peter Wilkinson will summarize Population Estimation.
- There was short discussion on whether the synopses written by the HRW should be captured in the Database Management System (DBMS). The consulting team working on the DBMS has called for data; if this is something that the HRW would want added to the DBMS now is the time to put it forward for inclusion.
  - One thought was that the synopsis highlighting key points may be useful to have in the DBMS.
  - It was determined that the information in the HRW synopses would contain similar information to the Executive Summaries of the documents. The Executive Summaries should be captured in the DBMS.
- There is a pre-existing list of projects, it would helpful to this list when determining which reports to summarize.

*Action:* Tetra Tech will check with Monika Mann to see if there is a pre-existing spreadsheet listing documents to be read and summarized.

#### HR Project for Sept. 21 "River Restoration" workshop

• Reclamation is hosting a River Restoration workshop to share techniques used in river restoration. The idea is to share information on techniques, treatments, and lessons learned with others doing work on the river system. A flier for the workshop was distributed to meeting attendees. There will be a working lunch at the workshop where HRW has been invited to show pictures of habitat restoration projects.

- There was concern that the "River Restoration" workshop would be used to replace a HRW and EMP proposed "State of the HR" workshop to evaluate and review past habitat restoration projects; a working lunch would not give enough time to evaluate and review habitat restoration projects. It was determined that the River Restoration workshop was not meant to replace the "State of the HR" workshop; the "River Restoration" workshop is meant to share techniques and the intent of the working lunch is to show very picture oriented results of habitat restoration pictures, not getting into depth on project design.
- The "River Restoration" workshop could broaden the HRW's toolbox and trigger thoughts regarding issues such as sustainability; the "State of the HR" workshop should take place shortly after the "River Restoration" workshop while ideas are still fresh in the workgroup's minds.
- There was question as to whether or not the HRW is expected to organize the lunch time presentation.

*Action:* Terina Perez will ask Yvette McKenna if she would like HRW to organize habitat restoration presentation for the River Restoration workshop.

### Discussion of future short and long term direction for HRW

- The question of where HRW members would like to see the HRW in the short and long term future was posed for discussion.
  - o The HRW needs to begin developing Scopes of Work (SOWs) for FY 2011.
    - A good place to start working on SOWs would be to review work that has been done with the "State of the HR" workshop. An hour or two at the end of the workshop can be used to work on SOWs.
    - The workshop could be used to compare and contrast different reaches and applications of techniques. The workshop would be for information purposes because it is not known if enough information exists for all projects to do a decent evaluation of the techniques. Coming up with good evaluation criteria for techniques would be useful for the future.
    - Maybe take some guidance from the recovery plans in terms of priority projects for each species.
    - It would be interesting to discuss how much of the current population's stability is due to habitat restoration projects versus other factors.
    - It was not known when the Program Management Team will call for SOWs for FY 2011.

Action: Terina Perez will find out when the PMT plans to call for SOWs.

- There should be a stronger working relationship between HRW and other workgroups in the future.
  - It was agreed that a stronger working relationship with other workgroups would be beneficial but there should be focused and productive discussions. Working on SOWs with other workgroups would help goals become more consistent and would give the opportunity for review.
  - It was said that there should be Program open houses for workgroups to be updated on Program projects from other workgroups.
- It was asked if there are elements in the RPA that address restorations. It might be beneficial to have the RPA discuss some type of habitat.
  - The goals of the Biological Opinion (BO) will need to be taken into consideration.
  - The best point to check if there are elements to address restoration is when the BO is in draft form and out for public comment.
- Looking at A&Rs comprehensively would help guide restoration. Anders Lundahl and Gina Dello Russo have started looking at the San Acacia A&R for future discussion points. Recommendations from the peer review include "next steps" and suggestions on incorporations to make a better product.

- The HRW planned the "State of the HR" workshop.
  - The workshop will be on Wednesday, September 22, 2010 from 8:30 am to 3:30 pm; meeting attendees should bring a lunch.
  - Rick Billings and Gina Dello Russo will work on an agenda.
  - Shapefiles, River Reach maps, and visuals of work that has been done would be beneficial for the workshop. Projects in the area have been done contractors; it was not known if contractors would be able to supply these visuals.

*Action*: Terina Perez will convey the need for visuals from contractors and the need for administrative support for the "State of the HR" workshop to Yvette McKenna.
