Meeting Summary:

- Gina Dello Russo brought the meeting to order. The agenda was approved with an addition of a CC Update and Potential SAR Scope of Work (both to be added to the Program update).
- The September 22nd, 2011 San Acacia Reach (SAR) work group meeting notes were approved with no changes.
- The majority of the September action items were completed as assigned; however, 5 remain ongoing/in progress.
- In a working session, attendees reviewed the Draft Floodplain Land Use White Paper. Changes and edits were made to the document using tracked-changes. The work group thanked Terina for the fabulous job she did in completing the white paper. SAR members were assigned action items to continue review of the draft white paper the intent is to have all sections near final state by early January. The recommendation and alternatives sections won't be reviewed until the Corps' floodplain project product is available. While the draft white paper is thorough and detailed, it was suggested that it be condensed where possible (especially the background section and some of the Positions of Interested Parties (ex. FEMA)) since the white paper should ideally only be a few pages in length.
- In the report of the Program's Open House/Technical Sessions it was shared that several hundred people participated in Saturday's events and activities. It was a very successful day. On Friday, 45 people attended one or more of the technical sessions. Gina's presentation was after lunch. The presentation expanded on the work shop presentation from the June roundtable. Gina introduced listeners to the San Acacia Reach and the unique features and issues encountered there. Listeners were introduced to the work group background/history and objectives. Gina explained the 6 resource management issues that were identified and targeted for white papers. The remainder of the talk focused on the floodplain encroachment potential issues and the work that the work group has accomplished.
- The update on the Corps' *Floodplain Encroachment Project* products and work group co-chair discussions were both postponed.
- In the Program update, it was shared that the EC will be meeting all day on November 3rd and half day on November 4th at the Corps. The agenda is focused on addressing the Program path (recovery implementation program). There is a Work Group Appreciation Brunch scheduled for November 15th from 9:00am to 11:30am at Reclamation. Attendance is limited to just primary and alternate agency representatives for the work groups. The HRW meeting is to directly follow. The deadline for all new FY12 scopes is December 16th, 2011. The development of the 2010-2011 Program Report will start as the 2008-2009 Program Report wraps up. The expected completion date is summer 2012.

o In an update from the CC meeting yesterday, it was shared that the SAR floodplain project does not rank high on the potential funding list even though it is the work group's only priority. Members expressed frustration and disappointment that the work group, especially as an ad hoc work group, is not getting the Program support or funding that would allow for completion of tasks. The CC did suggest the work group consider alternate funding sources (ex. Water Smart). However, each member has other work to do and most are already involved in other Program groups. It was suggested the work group evaluate what can be accomplished and whether or not it makes sense to reduce meetings or consider disbanding due to lack of momentum.

 - O Yvette McKenna said it would be helpful for the work group to provide a justification summary stating how the project could help to meet BiOp requirements or Recovery Plan criteria.

 - Yvette confirmed that non-signatory participants are not eligible to hold work group cochair positions.
- Terina Perez will follow up with some potential leads on guidance (clarification on potential wording for a scope of work) for developing the socio-economic analysis piece of the SAR floodplain project.

 ongoing; In progress... will review a couple of reports I expect to receive soon from a professor at UNM
 - The FY12 Scope of Work deadline is December 16th. The SAR work group has only the one project to build on the Corps' floodplain land use project and complete the final step (using the Corps' results) of determining encroachment trends (result of 10 homes, 50 homes, 100 homes, etc.) and run scenarios to see potential changes flow paths. The work group also added a socio-economic piece to the project. This project would then inform the recommendations and alternatives in the floodplain encroachment white paper.
 - o In order to submit a scope by the December 16th deadline, the description paragraph(s) of the Corps' product and the discussion with UNM on what socio-economic analysis might look like including any tasks related to the socio-economic portion are needed as soon as possible.
 - o It was shared that the local MRG Levee Task Force chartered UNM to research impacts in terms of flood insurance.
- Gina Dello Russo will follow up with Bill Borthwick to make sure he understands the work group's perceptive on the FEMA maps and how the work group will proceed without attending the CAPSSE meeting. *on going*;

O The floodplain maps for Socorro have been received by Socorro County. The maps have not been "locked in" yet so residents still have a chance to get the lower insurance rate.

o It is unknown if anyone can get a copy of those maps for reference; those interested were referred to Bear Albrecht.

Floodplain Land Use white paper

- o In a working session, attendees reviewed the Draft Floodplain Land Use White Paper. Changes and edits were made to the document using tracked-changes. The intent was to systematically review the draft document making improvements as needed. The work group thanked Terina for the fabulous job she did in completing the white paper.
 - *Effective Parties List:*
 - It was suggested that all the federal agencies be listed together, instead of breaking them out into action agencies, land management agencies, etc.
 - Attendees added the following groups to the list: NRCS, MRGCD, NMDA, NMSF, SWCD.
 - Primary Issues:
 - Attendees discussed the bulleted list of issues and made clarification changes.
 - Attendees agreed to change the phrasing of the second bullet (regarding the pressure on levee system) to: *Increased pressure on levee system by channel and floodplain obstructions*.
 - Attendees discussed the potential liability issues from encroachment and any flooding. Not only are the involved agencies liable, but the private citizens and local community share in the responsibility. This is especially true when considering the safety issues and safety issues to human life in areas that are prone to flooding.
 - *Position of interested parties:*
 - It was suggested that a disclaimer be added to the top of the *Position of Interested Parties* section in order to clarify the sources of information and the compilation process.
 - It was also suggested that the position paragraphs could be distilled down or even listed in bulleted format.

 Attendees added the following agencies to the Interested Parties list: Bureau of Land Management (BLM); NRCS (maybe put under the landowner section?); New Mexico Institute of Mining and Technology (NMT); New Mexico Department of Game and Fish (NMDGF); Floodplain Land Owners; Armendaris; and the Railroad.

Miscellaneous:

- Attendees discussed that the draft white paper is thorough and detailed but it was suggested that it be condensed where possible (especially the background section and some of the Positions of Interested Parties (ex. FEMA)) since the white paper should ideally only be a few pages in length.
- It was suggested the review of the recommendations and alternative sections be put on hold until the Corps' Floodplain Project Product is available (expected early December).

Report out on the Open House/Technical Session:

- o On Friday (Technical Sessions), 45 people attended one or more of the technical presentations. Gina's presentation was after lunch. The presentation expanded on the work shop presentation from the June roundtable. Gina introduced listeners to the San Acacia Reach and the unique features and issues encountered there. Listeners were introduced to the work group background/history and objectives. Gina explained the 6 resource management issues that were identified and targeted for white papers. The remainder of the talk focused on the floodplain encroachment potential issues and the work that the work group has accomplished.
 - There were several interesting questions in response to the SAR presentation. One person questioned if the San Acacia reach would/could ever realistically reach 10,000 cfs. And another question focused on the perspective that encroachment should be more of an issue in the northern reaches.
 - Gina responded to the questions by explaining that yes, the San Acacia reach could realistically reach 10,000 cfs and historically has even been as high as 40,000+cfs. In In Isleta and Albuquerque, 10,000 cfs flows can be accommodated by building up levees but in there is only one levee in San Acacia and there is no intention of ever

building a levee on the east side. Floodplain encroachment is less of issue in Isleta and Albuquerque due to land ownership. San Acacia has the greatest potential for floodplain encroachment.

o It was shared that several hundred people participated in Saturday's events and activities. It was a very successful day.

Update on the Corps' Floodplain Encroachment Project products:

o Ryan Gronewold was unable to attend today's meeting so the update on the Corps' floodplain encroachment project was postponed.

Action: Monica Sanchez will request Ryan Gronewold send an update on the Floodplain Encroachment Project products to the SAR work group via email.

Co-chair Discussion:

o It was suggested the co-chair discussion be tabled until after the New Year. The work group does not yet know how long they will continue to meet and there needs to be clarity on the 2012 work plan.

Program Update

- The EC will be meeting all day on November 3rd and half day on November 4th at the Corps. The agenda is focused on addressing the Program path (recovery implementation program).
- There is a Work Group Appreciation Brunch scheduled for November 15th from 9:00am to 11:30am at Reclamation. Attendance is limited to just primary and alternate agency representatives for the work groups.
 - o The HRW meeting is to directly follow.
- The deadline for all new FY12 scopes is December 16th, 2011.
- The development of the 2010-2011 Program Report will start as the 2008-2009 Program Report wraps up. The expected completion date is summer 2012.
- An update on yesterday's CC meeting was shared.
 - The SAR project does not rank high on the funding list. Even with a justification on how the project supports BO requirements, it is assumed that the project will not be reprioritized.
 - o Gina explained that she asked the CC how ad-hoc (short-term) work groups were supposed to make progress if Program support was lacking. The Floodplain Land Use project has been the work group's only project for the last 2 years. She also let the CC know that the work group was considering disbanding due to lack of progress. While one of the problems is the limited funding, the CC recommended the work group seek alternate funding sources to accomplish their work (Water Smart). It was interesting to note that no other work group received the suggestion to seek other funding.
 - The issues are important, but without decision-maker support and some funding available, it is nearly impossible to make forward momentum. This is especially true for the short-term, ad hoc work groups.
 - Members discussed being frustrated and discouraged because not funding the project impacts the quality of the white paper and means the work group really wasn't able to complete their objectives.
