The Non-federal Co-Chair, Rick Billings, chaired the meeting, with support of the Interim Program Manager, and two of the PMT members.

Signatories in attendance were:

- Albuquerque Bernalillo County Water Utility Authority
- New Mexico Department of Game and Fish
- New Mexico Interstate Stream Commission
- New Mexico Office of the Attorney General
- U.S. Fish and Wildlife Service

Because there was not a quorum no decisions were made. However, no changes to meeting summary for June 13, 2013 were noted by those in attendance.
