# **Meeting notes**

- DBMS training is tentatively scheduled for November 2013
- PM reported that no budget has been approved by Congress for Reclamation
- FY13 procurements are "on track" to be awarded before end of FY

- Award notifications will be tracked and posted in a data file on DBMS
  - Reminder that final reports for all grants ending September 30, 2013 are due 90 after closing
- The Annual Report 2010-2011 contract has been extended to December 31, 2013
  - A draft for review is due from the contractor October 1, 2013
  - Comments from Program will be due to the COR before November 5, 2013
  - Final, printed copies of report to be available December 20, 2013, under the contract extension
- 3<sup>rd</sup> Party procurement package has been re-submitted for acquisitions review for FY2014
- The on-line tour of the Database Management System (DBMS) has generated questions from CC:
  - Seek alternative (if possible) to zip. files as some members of the CC has expressed inability to access such files
  - \*PM will draft process for CC to present to EC regarding:
    - DBMS uploading procedures/requests
    - Granting access to contractors and what level access
      - Time limitations for access are the responsibility of the requesting agency
    - Review of the sensitivity levels and how documents are assigned those levels
