Meeting Summary

Introductions and agenda approval: Rick Billings brought the meeting to order and introductions were made. The agenda was reviewed and approved with no changes. Decision items were postponed until a quorum was confirmed.

Coordination Committee (CC) Action Items and Decisions Review

- June 11th Decisions
 - There were no comments on the March 5th CC decision items.
- June 11th Actions
 - Ali Saenz will send Lacy Levine a cost share description and reminder email; the cost share template will be attached. – *complete*;
 - All the pertinent information was provided to the NM Department of Agriculture (NMDA), who has submitted their FY2013 cost share report.
 - Ali Saenz will email the continuing/ongoing work groups asking for updated participant/agency representation lists and any changes to the work group charter. – complete;
 - The Science Work Group (ScW) is the only work group that has provided the requested information. However, Habitat Restoration Work Group (HRW) did not meet last month.

- Ali Saenz will ask Stacey Stanford to confirm the total amount of minnow salvaged in the Middle Rio Grande for inclusion in the 2013 Program Report (page 10, Program Accomplishments, bullet #6). – complete;
 - There was an error of an extra digit the typo has been corrected.

Approval of the June 11th, 2014 CC Meeting Summary

Announcements and Agency Updates

- Reclamation:
 - Stacey Stanford has been hired by Reclamation as a MRG Biologist. The position details are still being finalized, but it is likely that she will continue to support Program work with potential detail to the Service.
 - Regarding the consultation, Reclamation continues to work on progressing the hydrologic objective(s), other water acquisition and water management plans
 - Regarding the potential litigation, Reclamation expects to be sued on or around July 11th.
 There is no idea how the Colorado piece will be included, if at all.
 - Regarding timeframes if sued, it was shared that it is hard to predict when court
 decisions might be handed down. However, preliminary injunctions could
 happen quicker, but even those hearings could still take quite a while.
 - In response to a question on continuing Program work during litigation, it was shared that the expectation is that Program activities will be ongoing/continued on simultaneously during proceedings. It is assumed that a lawsuit won't directly change the current Program path, at least initially.
 - An MOU or MOA (Memorandum of Agreement) could be used to provide some level of certainty to the Service and could possibly be a way to achieve a quicker "incremental" Biological Opinion (BO). This option is being considered in potential strategies.
- *U.S. Army Corps of Engineers (Corps):*
 - The Corps is exploring Program needs and working with their Office of Counsel to determine how to help accomplish the work through the Corps' authorization. The Corps remains vested in supporting the Program and Recovery Implementation Program (RIP) through appropriations and continued attendance and participation in all levels of the Program, including the Minnow Action Team (MAT).

- It has been suggested that a Memorandum of Understanding (MOU) between the Corps and Reclamation could be useful to cover how both agencies can use funding "together" to accomplish Program objectives.
- o As with Reclamation, the Corps' assumes it will also be sued around the same time.
- It is assumed that the Corps' funding will be "ok" in FY2016, but there is the possibility that the Albuquerque region will be "out competed" by California resulting in a redistribution of the funding.

• State:

- The State is also dedicated to working on the hydrologic objectives making them more robust. Reclamation, Middle Rio Grande Conservancy District (MRGCD), and Interstate Stream Commission (ISC), remain engaged in the MRSI (Matrices of River System Impacts) to evaluate the effects of the proposed conservation measures and improving/enhancing the RIP Action Plan to firm up water management commitments.
 - An MOU/MOA might help get some of those commitments down.

Update on MAT 2014 Summer Emergency Recommendations

- The 2014 summer recommendations are similar to those from last year: continuous flow in the Angostura Reach down to Isleta and to the extent possible, maintain refugia past the Isleta and San Acacia dams.
 - Last year, the river would have dried a lot more if a small flow hadn't been maintained pasted the dams and at the drain outfalls.
- As far as reporting, the group is working on finalizing the 2013 MAT Report and starting the planning/development of the 2014 MAT Report.
- The MAT is providing the interaction/communication between the biologists, hydrologists, and water managers. However, the on-the-ground technical work (including research, monitoring, surveys, studies, etc.) is not their task; those still need to be addressed through the ScW and HRW groups and eventually the Adaptive Management Team.

Review Final Draft Program 2013 Annual Report Update

- A draft copy of the 2013 Program Annual Report was provided as a read ahead for today's meeting.
- In a working session with the document projected, CC members provided feedback and suggest edits. Edits included (but are not limited to):
 - 1. It was suggested the Executive Summary include a few clarification sentences to indicate where in the RIP process the Program is. It was also suggested the references to the RIP be written in future tense. Other suggested language included:
 - The RIP has not been implemented yet. Once established, the RIP is expected to be... envisioned to be...
 - The RIP is currently being developed...
 - Many of the activities described in this report for FY2013 are aimed at the eventual support of the RIP.
 - 2. Check the formatting of the tables to make sure the information was aligned.
 - 3. FY2013 was the first year with MAT involvement and the MAT group should be referenced in the Water Operations section(s).
 - Since the MAT is an ad hoc group of the EC and not an officially chartered Program group, it was suggested that a new section be created to reference the MAT work. It was clarified that the MAT should only be referenced as "the Minnow Action Team."

- o For example, 3.2.1 could be the new MAT section and 3.2.2 could be created for Reclamation's supplemental water program.
- 4. It was suggested that website links for referenced documents be included in the report.
- 5. It was agreed that the Southwestern Willow Flycatcher (SWFL) table in Section 3.4.4 is overly detailed for this report. It was suggested that SWFL information and annual updates be provided in the same format (text summary) as the rest of the document.
- 6. It was suggested that the heading of the Collaborative Program Contacts (page 3) be changed to Program Management Team and delete the phone numbers and emails. A footnote could be added specifying that these were the individuals in those positions for the specific year.
- For future years, it might be helpful to include a table of agencies involvement with specific groups/committees to show how everyone is participating together to accomplish the Program's goals and objectives.

Identify and Develop EC Presentation/Updates Recommendation List

- It was suggested at the June 11th CC meeting that members identify and recommend possible EC presentations and updates to occur at future EC meetings. The CC reviewed the brainstormed list of suggestions from the June meeting. Only one new suggestion was offered during the meeting:
 - o 2014 Drought Relief Bill (once finalized, contact Udall's staff Kaveh Sadeghzadeh?)

2013 Non-federal Cost Share Report

- This remains an ongoing request. Only 3 2013 Cost Shares have been submitted to date.
- It was suggested that the CC begin working on the FY2015 Work Plan in September.

CPUE Workshop

• Attendees briefly discussed workshop planning language in order to best represent the intentions and potentially assist in securing funding. For example, the expert panel is intended as more of a "peer review" panel versus an "advisory panel."

Significant Non-Decision Items to Brief EC
