## **Decisions**

## **Meeting Summary**

  - This action is no longer relevant as Reclamation has offered to oversee the funding process as a Program event.

## Population Monitoring (CPUE) Workshop Planning

- As previously announced, Reclamation has offered to fund the Population Monitoring (CPUE)
   Workshop as a Program effort. There are some contracting issues that will need to be worked out.
  - O The original intent was to contract individually with each expert (as exampled by the San Juan program) but Reclamation is not able to do that. Reclamation will have to contract with an agency. This presents a new difficulty that will have to be worked through.
  - o The workshop planning group will be having a series of working meetings to discuss the new challenges, write a scope and finish defining the questions for the experts.
  - Attendees discussed the need to have the workshop scope submitted in time and be well written and contain the necessary level of detail in order for it to proceed through Reclamation's contracting process in a timely fashion.
    - The hope is to issue a contract that includes the initial workshop as well as follow up workshops/reports/investigation/etc. in order to have the biological expertise in place to achieve resolution. It is more efficient to write the initial contract with open Option Years so as to provide the necessary coverage/flexibility should timelines get shifted.
      - The scope of work will have to be submitted in early September in order to host the initial workshop in summer 2015. The timeframes are partly dependent on when the experts (ex. professors) are available.

## Review and Revise Draft Annual Program Report 2013

- The Draft 2013 Program Annual Report was provided as a read ahead. All previously identified edits and changes have been addressed. It was proposed that any additional review be handled via email as the August EC meeting was cancelled. This would allow members more time to address their action items related to the Annual Report.
- Attendees discussed the EC suggestion to include all Program contributions so that the Annual Report is a more "complete picture" for congress. After discussion, attendees recommended that the addition of other contributions be addressed in the 2014 Annual Report because the 2013

- Annual Report is nearly done. Agencies would have to submit their financial numbers, project summaries, etc. and there is not enough time to accomplish this for the 2013 Report.
- Attendees also discussed possibly hiring a contractor to oversee the writing of the 2014 and possibly other future reports. It might be possible to have a contract in place for the 2014 report cycle this would help "bridge" the transition to the Recovery Implementation Program (RIP) as the Executive Director's office might be "up and functioning" in time to oversee the report.

## Identify and Develop EC Presentation/Updates Recommendation List

- It was suggested at the June 11<sup>th</sup> CC meeting that members identify and recommend possible EC presentations and updates to occur at future EC meetings. Attendees reviewed the brainstormed list of suggestions from the June meeting and assigned points of contact for each.
- The compiled list of presentation options will be presented to the EC for consideration and selection.
- During discussion, attendees added (1) the Corps' Sedimentation Modeling (completed by Tetra Tech) and (2) Reclamation's Climate Change Report to the recommended presentation list.
- It was suggested that the Valle de Oro be considered for the September EC meeting; if that is not feasible, then the ABCWUA Water Treatment could be prepared to present.

## Database Management Systems (DBMS) Progress Report

- The contractor is proceeding with moving the database from a Silverlight to .net platform. This is expected to resolve many of the "user interface" issues. The transition will be completed no later than the end of October, but the hope is that it will be done earlier.
  - o It was suggested that once the DBMS platform transition from Silverlight to .net is completed, a brief presentation and "walk through of changes" could be provided to the EC at their October or November meeting.
- The current contract covers through October 2015. Attendees supported the Corps beginning the contracting process to continue supporting and funding the database.
- Attendees briefly discussed that the database needs to be regularly updated with the newest reports and documents in order to be the most useful. It is up to the agencies to make sure that available reports are being provided.
- The contractor was issued a separate task to access all the population monitoring data that is housed on Dr. Goodman's website so that this information would not be lost.
  - At the present time, there are still a lot of duplications that have to be worked through.
     Completion of this task in on hold for now but it will eventually be incorporated into the database.
- A member shared a positive database experience they were able to find a specific report that had been referenced in another document.

## Review and Update Collaborative Program Work Plan for FY2015

- The current budget estimate for FY2015 is approximately \$3 million. However, there were some 2014 contracts that weren't awarded on time and will have to be taken off the top of the FY2015 budget (ex. genetics).
- The FY2015 Program Work Plan discussion proceeded in closed session. Contractors were excused. Please contact your CC member for information and details on this discussion.
