  - Tamarisk Beetle Update:
    - A tamarisk beetle presentation has been scheduled for the February HRW meeting. It has been suggested that the presentation (meeting agenda) be distributed Program-wide to invite anyone potentially interested.
  - Cochiti Lake Sedimentation Assessment:
    - Ryan Gronewold provided the following information/clarification on the Cochiti Lake Sedimentation and other sediment work being completed by the Corps:
      - 1. We [the Corps] implemented a new Elevation-Surface Area-Capacity table for Cochiti Lake in January of 2013. This involved a combination of topographic (and bathymetric) surveys of the entire Cochiti Lake pool. We periodically do this for all of our reservoirs every 5-10 years in order to measure the amount of sediment accumulation within the reservoir.
      - O 2. As a part of the Area-Capacity table implementation, Wilson Engineering developed a digital terrain model (DTM) of the Cochiti pool based on survey data from 2012. In addition to the 2012 DTM, Wilson created a DTM using available data from before Cochiti Dam was built. These DTM's allow us to visualize the changes to the ground surface since Cochiti was

- built (John Peterson and Wilson have given several presentations on this). I don't know of any formal analysis or report for this work.
- o 3. Following the Las Conchas fire in 2011, we [the Corps] have conducted rangeline surveys within White Rock Canyon downstream to the headwaters of the main Cochiti pool. We have conducted these surveys on a yearly basis (previously every 5-10 years as a part of the normal Area-Capacity tables) in order to more closely monitor the amount of sediment entering the lake since the Las Conchas fire. There are field trip reports (prepared by Wolf Engineering who did the surveys) from each of these surveys that include photos of the rangelines and of many of the tributary confluences, as well as a few observations of river conditions by the survey crew.
- O 4. While we have these yearly rangeline survey data, we have not incorporated this data into any type of analysis or report. In my initial inspection of these rangeline surveys, I have not noted any drastic increase in sediment inflow into the reservoir pool.
- 5. The Cochiti Baseline Study includes some analysis of sediment accumulation within the reservoir under different operating scenarios (fluctuating pool elevations, etc.). Requests for any information would need to be made to the Pueblo.
- It was mentioned that Ryan Gronewold gave a presentation to the EC after the survey was completed.
- Some attendees expressed the opinion that they disagree with the statement that there is "not a lot of sediment inflow."
  - o The Corps hasn't started looking at the inflow issue or how to improve the sediment input into the river.
- The EC presentation in February will cover the sediment analysis on the tributaries.

# **Update EC Presentation/Updates Recommendation List**

- The CC continues to develop and refine a list of potential presentations for EC meetings.
- Suggested Modifications to the Presentation List:
  - *The Cochiti Sediment* presentation will be replaced with the *River Sedimentation* presentation.

  - o The suggested Rio Grande Compact Review presentation title has been modified to: Rio Grande Compact presentation (remove the word "review.").
