- Approval of the 2020 ScW/HR Work Plan with addition of a plan for sunsetting the work group and moving towards the Science and Technical Network (STN)
- Approval of the 2020 Population Monitoring Work Group (PMWG) Work Plan
- Approval of the Buckman Direct Diversion (BDD) membership request
