## **Meeting Minutes**

## Welcome, Introductions, and Agenda Review

The FPC Non-Federal Co-Chair, Grace Haggerty, opened the meeting, led introductions and reviewed the January 27, 2022 meeting agenda. The FY22 omnibus appropriations bill had not been signed and USACE may be on a continuing resolution for FY22, which diminishes funding for MRGESCP-related activities. The FPC will be discussing strategies to support USACE.

The PST introduced new member Kevin Shelley.

### November 19, 2021 Meeting Review

Debbie L. reviewed minutes and action items from the

November 19, 2021 meeting. Summary updates to the November action items are below:

- The Executive Committee (EC) Co-Chairs were informed Grace H. and Debra Hill would be staying on as the FPC Non-Federal and Federal Co-Charis, respectively.
- There were no comments from the FPC on the Signatory Activity Input Form.
- The PST and Science and Adaptive Management Information System (SAMIS) Development Team have discussed further development to build cost-share and additional tracking capabilities. Those developments would not take place until after March, when the current PST contractor, WEST, Inc., begins their new contract.
- The PST has been collecting Signatory Activity Input Forms for 2021.
- The revised cost share memo from U.S. Bureau of Reclamation (Reclamation) was sent to the EC.
- ✓ **Decision**: The FPC approved the November 19, 2021 FPC meeting minutes

### Summary of December EC Meeting

Debbie L. gave an update from the EC meeting on December 7, 2021. Summary points are below:

- The EC approved an updated Long-Term Plan, which includes a list of projects recommended by the MRGESCP. The list includes projects USACE intended to fund in 2022.
- The EC approved the Annual Evaluation Process, which is a quick evaluation of program operations to determine if there are improvements that make the MRGESCP more effective, efficient, and relevant.

### Update on USACE FY22 Funding

Michael Porter, USACE, updated the FPC on the state of USACE's FY22 funding. The continuing resolution expires February 18, 2022, and USACE anticipates U.S. Congress will take action on or before that date. U.S. Congress may release a budget or USACE will remain under continuing resolution. If a budget is decided, USACE will likely need a minimum of two months before it receives funding for contracts. USACE expected 1.94 million from the President's Budget. If USACE receives a budget, it should be spent within the fiscal year. Once USACE funds its priority contracts, it will fund other activities on its list.

### FY22 Priority Projects to be Funded

Debbie L. opened further discussion on USACE's FY22 priority projects. Michael P. provided a spreadsheet with cost estimates for the following priority projects:

- BEMP Site Monitoring (\$427K)
- Program Portal (\$208K)
- Gages at San Marcial, San Acacia, and Rio Puerco (\$175K)
- Rio Grande Nature Center Sediment Gage (\$9K)
- Alameda Gage Water Temperature Probe (\$3K)

Debbie L. is getting a further cost breakdown for the Program Portal from U.S. Geological Survey to determine cost for select priority maintenance and development. Mark Kelly with ABCWUA (current contract holder) stated ABCWUA would be able to continue to fund baseline maintenance (approximately \$15K). Reclamation could also provide Program Portal funding (at approximately \$25K). The revised estimate for maintenance of the Program Portal may be closer to \$75K a year. Priority needs for the Program Portal are to update the datasets and geospatial mapper, and make the search function faster.

Debbie L. spoke with Reclamation and ABCWUA about funding the gages, as they use data from them. Mark K. is not sure if ABCWUA can fund any gages. Anne Marken, MRGCD, stated the MRGCD would have approximately \$35K to put towards projects this year. She will confirm whether the MRGCD can help fund priority projects. MRGCD regularly funds BEMP each year and may be able to allocate more funds to them. NMISC is working on pushing through a contract with BEMP and the University of New Mexico. No additional funding from NMISC is expected. The Alameda gage should be a priority as it has a continuous record. MRGCD may have more funding available after June. Other signatories may have funding capability. Debbie L. has been discussing with individual signatories options on funding projects that would have been funded by USACE if no FY22 budget is passed.

The FPC concluded funding priorities are baseline funding of the Program Portal, BEMP monitoring, and priority gages (e.g., San Marcial, San Acacia, Rio Puerco, and Alameda). The PST will get costs for other priority improvements to the Program Portal in the case additional funding becomes available.

- Collaborative Opportunity: Signatories should identify the USACE gages providing data for their work to assess the priority gages to fund.

- Collaborative Opportunity: Other signatories may have funding capability for USACE FY22 priority projects. Signatories should contact Debbie L. to discuss funding opportunities. Debbie L. will also be actively reaching out to funding agencies to discuss opportunities and options.

### **BEMP Funding**

Kim E. opened discussion on BEMP funding in FY22-23. BEMP did not receive FY21 funding from USACE and dropped to 26 sites. For FY22-23, there is a \$150K shortfall to maintain staff at current levels, but no vegetation data would be collected and additional sites/schools would be dropped. With additional

funding, BEMP would prioritize datasets such as vegetation. BEMP is budgeting \$100K in foundation funds, and will continue to diversify its funding through smaller grants. BEMP prefers securing staff and core sites to adding new datasets or sites. BEMP is asking for input for priorities on their services and sites, to inform the decisions about which to keep. Anne M. will confirm what additional funding MRGCD can provide. To maintain the current service level (maintaining minimal sites and current datasets), BEMP needs \$250-300K. Among the datasets dropped are fuel load, fire hazard, and cottonwood monitoring. BEMP will continue monitoring water quality.

BEMP will be reaching out to ABCWUA, which is a former funder, and continue applying for grants. Debbie L. asked if there are organizations using BEMP data who are not funders. BEMP data is publically available, so it is not always clear who is using the data. BEMP should reach out to New Mexico Department of the Environment, New Mexico Department of Game & Fish, and Buckman Direct Diversion.

Following the meeting, Debbie L. will coordinate with the other signatories to communicate the FPC's priorities and determine funding availability. Debbie L. will message that available funding should be used for the Alameda water temperature gage and BEMP. Kim E. will send a list of BEMP sites and data collected to the SAMC for prioritization at an upcoming meeting.

Debbie L. opened discussion on the 2021 Annual Program Evaluation. The PST provided the survey in the read-aheads, which went out to all attendees of the FPC. The four questions cover whether the FPC is functioning as intended, whether the Co-Chairs are engaged, whether the FPC is on track to complete tasks in the Work Plan, and whether there are other issues that need to be addressed. If needed, the PST will follow up with some respondents to get more details. The form is due **February 11, 2022**. The PST will compile responses and propose potential changes at the EC meeting on **March 23, 2022**.
